Kem Cho Sharjah! SpiceJet Launches Non-Stop Flights from Ahmedabad to Sharjah

SpiceJet Leverages Limited Bilateral Capacity to Strengthen Its UAE Footprint

GURUGRAM, January 20, 2025: SpiceJet will launch non-stop flights connecting Ahmedabad with Sharjah starting February 5, 2026. The new service further expands the airline's international network and strengthens air connectivity between India and the UAE. With this addition, Sharjah becomes the airline's second destination in the UAE after Dubai.

The new service will operate five days a week, except Tuesday and Wednesday, offering passengers' greater flexibility and convenience for travel to the Middle East. Ahmedabad is a key economic and cultural hub with strong trade, tourism, and diaspora links to the UAE, making Sharjah a natural and strategic addition to SpiceJet's international network.

The Ahmedabad-Sharjah flights will complement SpiceJet's existing international services and cater to the growing demand from business travellers, tourists, and the large Indian expatriate community in the region.

Debojo Maharshi, Chief Business Officer, SpiceJet, said, "Sharjah's position as the cultural capital of the UAE and a key regional hub makes it an important addition to our network. The launch of this service reflects the growing demand for travel between India and the UAE, and we remain committed to expanding connectivity across the region."

Sharjah is the third-largest emirate of the United Arab Emirates. It is the only emirate that shares borders with all six of the other emirates. Visitors to Sharjah can explore a rich mix of heritage sites, museums and mosques. The emirate's east coast is dotted with archaeological sites dating back to as early as the second millennium BCE.
