I, Prabhat Maheshwari, Partner, GMJ & Associates, Company Secretaries, Mumbai was duly appointed as the Scrutinizer by the Board of Directors of ASI Industries Limited ("the Company") having it's registered office at Marathon Innova, 'A' Wing, 7th Floor, Off. G. K. Marg, Lower Parel, Mumbai – 400 013, pursuant to the provisions of Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and Section 108 and 110 of Companies Act, 2013 read with Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014 ("the Rules") and other applicable provisions of the Act and the Rules, General Circular Nos. 14/2020 dated 8th April, 2020 and 17/2020 dated 12th April, 2020 read with other relevant circulars, inclusions General Circular No. 10/2021 dated 23rd June, 2021, issued by the Ministry of Corporate Affairs ("MCA Circulars"), Secretarial Standard on General Meetings ("SS-2") issued by the Institute of Company Secretaries of India and other applicable laws, rules and regulations (including any statutory medication or re-enactment thereof for the time being in force and as amended from time to time) to report on the remote e-voting made by the members in respect of the proposed resolution on Item No. 1 as set out in the Notice of the Postal Ballot dated 12th November, 2021.



As required under Section 108 and 110 of the Act, Notice of the Postal Ballot dated 12th November, 2021 along with Explanatory Statement under Section 102 of the Act was dispatched to the members on 17th November, 2021 through electronic mode to those members whose e-mail addresses were registered with the Company/Depositories and whose names appeared in the Register of Members / List of Beneficial Owners as received from National Securities Depository Limited ("NSDL") / Central Depository Services (India) Limited ("CDSL") as on cut-off date i.e. Monday, 15th November, 2021.

The Management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and Rules framed thereunder relating to voting through electronic means (nematic e-voting) on the resolution contained in the Notice of the Postal Ballot by the members of the company. Our responsibility, as a Scrutinizer for the remate e-voting process is restricted to make a Scrutinizer's Report of the votes casted "in favour" or "against" the resolution as stated below on the report generated from the remote e-voting system provided by Central Depository Services Limited ("CDSL") the authorised agency engaged by Company to provide remote e-voting facility.

We hereby submit our Scrutinizer's Report on the results of remote e-voting as follows:

- The resolution was transacted through the process of remote e-voting. For the purpose of remote e-voting, the Company has engaged CDSL for its services;
- 2. The cut-off date for the purpose of identifying members who were entitled to vote on the resolution placed for approval, was Monday, 15th November, 2021;
- 3. The period for remote e-voting commenced on Friday, 19th November, 2021 at (9.00 A.M.) and ended on Saturday, 18th December, 2021 at (5.00 P.M.). The remote e-voting module was disabled by CDSL for voting thereafter;
- 4. Further, the votes cast through remote e-voting were unblocked by us on 20th December, 2021 at 10.54 A.M. in the presence of two witnesses Mr. Nitin Prajapati and Ms. Mansi Pandya, neither of whom was in the employment of the Company and e-voting summary statement was downloaded from the CDSL e-voting website;
- 5. The votes were also scrutinized for the purpose of eliminating invalid votes, if any;
- Our report on the results of remote e-voting is based on the data downloaded from the website of CDSL;



7. The data relating to e-voting process was reconciled with the records maintained by the Company/Registrar & Transfer Agents of the Company.
