Dear Sir/Mam,

In continuation of our earlier announcement dated February 17, 2025, wherein, it was stated that the Show Cause Notice (SCN) dated February 13, 2025, issued by the Securities and Exchange Board of India (SEBI), pertained to certain trading transactions in the equity shares of another BSE-listed company, undertaken by the Promoter of the Company, along with certain family members and associated entities, who were named as Noticees.

Subsequently, after due consideration of the facts, submissions, and material on record, SEBI passed Adjudication Order No. **Order/AK/GN/2025-26/31848–31890** dated **December 19, 2025**, which clearly records that **no adverse findings, directions, or penalties have been imposed** on the promoter, any family members, or associated entities. It is pertinent to bring to the notice of all stakeholders that certain persons, apparently acting with malafide intent, have circulated unauthorised and misleading communications in connection with the SCN, conducted selective campaigns, and sought to escalate this matter for objectives unrelated to the facts of the case; **while the Company itself was not even a noticee in the SEBI proceedings**, these communications have falsely portrayed the Company as being under scrutiny, selectively citing the Show Cause Notice while deliberately disregarding the factual position, evidently aimed at creating reputational damage, misleading investors, and influencing public perception and other stakeholders.

The SEBI Adjudication Order dated December 19, 2025, which explicitly records that **no adverse findings**, **directions**, **or penalties were imposed even on the Promoter**, **any family members**, **or associated entities**, has decisively exposed the baselessness of these narratives, representing a significant setback to attempts to distort facts and create unwarranted apprehension regarding the Company.

In light of the above, and to prevent any misunderstanding or misrepresentation among investors and the public, the Company **strongly advises all stakeholders to disregard any unverified, unauthorized, or selectively circulated communications** and to rely exclusively on **official disclosures** for accurate and complete information.
