Sub: Disclosure under Regulation 30 read with Para A of Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

Dear Sir/Mam,

This is with reference to our earlier announcement dated February 17, 2025, regarding the receipt of a Show Cause Notice (SCN) dated February 13, 2025, issued by the Securities and Exchange Board of India (SEBI). The SCN pertained to certain trading transactions in the equity shares of another BSE-listed company, undertaken by the Company, its Promoter, and certain associated persons, who were named as Noticee(s).

Following a detailed examination of the facts, submissions, and documents on record, SEBI issued **Adjudication Order No. Order/AK/GN/2025-26/31848–31890 dated December 19, 2025**, which clearly confirms that **no adverse findings, directions, or penalties** have been imposed on the Company, its Promoter, or any associated persons. Further, the Company wishes to highlight that certain persons, apparently acting with malafide intent, have circulated unauthorised and misleading communications relating to the SCN. These communications have selectively emphasized the issuance of the SCN while ignoring its factual outcome, falsely suggesting that the Company was under scrutiny concerning its businesses, governance, and other matters. Such misrepresentations appear intended to damage reputation, mislead investors, and influence public perception.

The SEBI Adjudication Order dated **December 19, 2025** decisively confirms that **no adverse findings, directions, or penalties** were imposed on the Promoter, family members, or associated entities, thereby exposing the baselessness of these narratives and representing a significant setback to any attempts to distort facts. In view of the above, the Company **strongly urges all stakeholders to disregard any unverified or unauthorized communications** and rely solely on **official disclosures** for accurate and complete information.

Further, the requisite details, as required under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, read with the SEBI Master Circular SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024, is enclosed as **Annexure I** to this letter.
