Sub: Disclosure under Regulation 30 read with Para A of Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

Dear Sir/Mam,

Please refer to our earlier announcement dated February 18, 2025, informing the receipt of Show Cause Notice (SCN) dated February 13, 2025, issued by the Securities and Exchange Board of India (SEBI), pertained to certain trading transactions in the equity shares of another BSE-listed company, undertaken by the Company, its Promoter, along with certain other associated persons, who were named as Noticee(s).

After careful consideration of all facts, submissions, and documents on record, SEBI issued Adjudication Order No. Order/AK/GN/2025-26/31848–31890 dated December 19, 2025, which explicitly confirms that **no adverse findings, directions, or penalties have been imposed** on the Company, its Promoter, along with certain other associated persons. The Company wishes to bring to the attention of all stakeholders that certain persons, apparently acting with malafide intent, have circulated unauthorised and misleading communications relating to the SCN, selectively emphasizing its issuance while ignoring the factual outcome. These communications have falsely portrayed the Company as being under scrutiny regarding its businesses, governance, and other matters, with an evident intention to **damage reputation**, **mislead investors**, and influence public perception.

The SEBI Adjudication Order dated December 19, 2025 explicitly confirms that no adverse findings, directions, or penalties were imposed on the Promoter, any family members, or associated entities. This decisively exposes the baselessness of such narratives and represents a significant setback to attempts to distort facts. In view of the above, the Company strongly urges all stakeholders to disregard any unverified or unauthorized communications and to rely solely on official disclosures for accurate and complete information.

Further the requisite details, as required under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, read with the SEBI Master Circular SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024, is enclosed as **Annexure I** to this letter.
