**Subject: Non submission of Share Holding Pattern under Regulation 31 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“Listing Regulations”) for the quarter ended December 31, 2025**

Dear Sir/ Madam,

We have to inform you that the Company is currently undergoing proceedings under the Insolvency and Bankruptcy Code, 2016 (“IBC”). The Hon’ble National Company Law Tribunal (“NCLT”), Mumbai Bench, vide its order dated February 1, 2024, admitted an application under Section 7 of the IBC against the Company, thereby commencing the Corporate Insolvency Resolution Process (“CIRP”) and the undersigned was appointed as an Interim Resolution Professional (“IRP”).

Subsequently, an appeal was filed before the Hon’ble National Company Law Appellate Tribunal (“NCLAT”) in Bhavesh Gandhi vs. Amluckie Investment Company Ltd., Company Appeal (AT) (Ins.) No. 244 of 2024. During the pendency of the appeal, the Hon’ble NCLAT, vide interim order dated February 12, 2024, had stayed the constitution of the Committee of Creditors (“CoC”). The Hon’ble NCLAT, Principal Bench, New Delhi, vide its order dated October 15, 2025, had vacated the stay and allowed withdrawal of the appeal. With the interim stay lifted, the CoC was constituted, and the Hon’ble NCLT approved the same. In the First (1<sup>st</sup>) Committee of Creditors meeting held on Monday, November 03, 2025, the members of the Committee of Creditors approved the appointment of Mr. Purusottam Behera, Interim Resolution Professional (IRP) as Resolution Professional (RP).

The erstwhile management has not made payment of the outstanding fee(s) as demanded by National Securities Depository Limited (NSDL), Central Depository Services Limited (CDSL) and Registrar and Transfer Agent (RTA) on account of which NSDL, CDSL and RTA have stopped providing BENPOS regarding shareholding of the Company. Thus, the Resolution Professional has been unable to submit the Share Holding Pattern for the quarter ended December 31, 2025 so as to comply with the Regulation 31 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“Listing Regulations”).
