Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, and in continuation of our earlier announcement dated 10th December, 2025, we are pleased to inform that the Company has been awarded an **additional Work Order** by the **Government of Maharashtra, State Health Assurance Society (SHAS)**, under the **(Integrated Ayushman Bharat–Pradhan Mantri Jan Arogya Yojana & Mahatma Jyotirao Phule Jan Arogya Yojana)** ("Authority").

The said Work Order pertains to the **printing of PVC Ayushman Cards** for the following **Eight (8) districts of Maharashtra State:**

The total contract value of the Work Order is ₹41.26 Lakhs (Rupees Forty-One Lakh Twenty-Six Thousand only), inclusive of GST, with a stipulated completion period of 180 days.

The Company further wishes to inform that it has also been awarded similar work orders for the printing and supply of Ayushman Cards in other States, including **Odisha, Haryana, Chhattisgarh, and Maharashtra**.
