**Subject: Disclosure under Regulation 30 of SEBI (LODR) Regulations, 2015 – Update on Legal Proceedings (Registration of FIR and Court Order).**

Ref: Our earlier intimation dated 27<sup>th</sup> December, 2025.

This is in continuation to our earlier intimation dated 27<sup>th</sup> December 2025, regarding the filing of a Police Complaint by the Company in connection with a land fraud transaction.

We wish to inform you of the following material developments in the said matter:

- Consequent to the Company's complaint, at the Police Station, Bamitha (District Chhatarpur), the Hon'ble Judicial Magistrate, First Class (JMFC), Rajnagar, District Chhatarpur, has taken cognizance of the matter and, vide order dated 20<sup>th</sup> January, 2026, has directed the freezing of the bank accounts of the accused persons wherein the proceeds of the crime are deposited.

**Impact of the Order:**

This judicial order legally secures the funds involved in the transaction (approx. ₹1.79 Crores as per FIR) and prevents any dissipation or withdrawal by the accused during the pendency of the investigation. The Company is now pursuing the necessary legal steps for the release/custody of these frozen funds.

The details required under **SEBI Circular No. SEBI/HO/CFD/CFD-PoD1/P/CIR/2023/123** are provided in **Annexure A**.
