1. We have reviewed the accompanying statement of unaudited standalone financial results of Onix Solar Energy Limited (Formerly known as ABC Gas (International) Limited) (the "Company") for the quarter ended December 31, 2025 (the "Statement") attached herewith, being submitted by the Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (the "Listing Regulations").
