Sub.: Intimation of acquisition of equity shares of J.B. Chemicals & Pharmaceuticals Limited

With reference to our earlier intimations dated 29th June 2025, 3rd July, 2025, 23rd September, 2025, 21st October, 2025 and 5th December, 2025 *inter alia* relating to acquisition of equity shares of J.B. Chemicals & Pharmaceuticals Limited (“**JB Chemicals**”), we would like to inform that on 21st January 2026, the Company has completed the acquisition of 7,44,81,519 equity shares of JB Chemicals, representing 46.39% of the equity share capital of JB Chemicals on a fully diluted basis, from Tau Investment Holdings Pte. Ltd. (“**Promoter Seller**”) pursuant to the share purchase agreement dated 29th June 2025 executed between the Company, the Promoter Seller and JB Chemicals, read with the addendum dated 3rd July, 2025. Accordingly, the Company has acquired control of JB Chemicals and has been classified as a ‘promoter’ w.e.f. 21st January, 2026.

Following the aforesaid acquisition, and together with 1,317 equity shares of JB Chemicals acquired by the Company under the open offer, the Company holds an aggregate of 7,44,82,836 equity shares of JB Chemicals, representing 46.39% of the equity share capital of JB Chemicals on a fully diluted basis.
