Furtherance to our earlier disclosure dated 27 June 2025 on the captioned subject, we would like to update that Mazagon Dock Shipbuilders Limited ("Company") has recently concluded the acquisition of the 16,49,16,229 fully paid ordinary shares (Sixteen Crore Forty-Nine Lakhs Sixteen Thousand Two Hundred and Twenty-Nine) representing 41.73% of the total number of shares in Colombo Dockyard PLC (CDPLC) pursuant to allotment of shares arising from unsubscribed rights shares (Onomichi's portion) by CDPLC. As part of the Tripartite Agreement entered with CDPLC and Onomichi Dockyard Co. Ltd., the Company is in the process of acquiring further shares from the existing shareholders of the CDPLC through a Mandatory offer pursuant to Rule 31(1) (a) of the Company Take-overs and Mergers Code 1995 (as amended in 2003) of Sri Lanka. Further developments in this regard will be updated to the Stock Exchanges in due course.
