

Outcome of Board of Directors' Meeting

In its meeting held on May 19, 2018, the Board of Directors approved the Q-4 and Annual results of Financial Year 2017-18.

The total income (net of Excise and GST) for Q-4 is Rs. 198.97 Cr and for 12 months Rs. 865.11 Cr showing an increase of 19% and 15% respectively over the corresponding period of previous fiscal.

Earnings Before Interest, Depreciation and Tax (EBIDT) and Profit Before Tax (PBT) for Q-4 is Rs. 10.14 Cr. and Rs. 1.68 Cr. For the FY, the EBIDT and PBT is Rs. 68.48 Cr and Rs. 15.29 Cr.

The Board of Directors recommended final dividend of Rs.0.125 per share i.e.. 12.5% on face value of equity share of Rs.1/- each, for the Financial Year ended 31st March, 2018, which is subject to the approval of shareholders in the ensuing Annual General Meeting of the Company.

Market & New Products:

NACL continues to grow in both domestic and export markets. In FY 2017-18, Domestic market grew by 10% over the previous year. Export division's sale have grown by 43% over previous year.

The company introduced two new products 'Signet and Fast spread'. Signet is fungicide which has application on two of the large area crops in India -Wheat & Rice. Fast spread is Japanese product which when mixed with pesticides help in their spread . The product introduced last year 'Atonik' and
