# শহরবাসীকে মেট্রো রেলের একাধিক উপহার দেবেন প্রধানমন্ত্রী

আর্থিক লিপি প্রতিবেদনঃ কলকাতা ছিল ভারতের প্রথম মেট্রো শহর। তবুও ১৯৮৪ থেকে ২০১৪ সাল পর্যন্ত, তিন দশকে মাত্র ২৭.৯৯ কিলোমিটার অংশে মেট্রো নির্মিত হয়েছিল। প্রধানমন্ত্রী মোদীর নেতৃত্বে গত ১০ বছরে ৪৫ কিলোমিটার অংশে মেট্রো রেল যোগ করা হয়েছে, যা পূর্ববর্তী ৩০ বছরের তুলনায় ১৬১ শতাংশ বেশি। প্রথম মেট্রো শহর থেকে এখন দ্রুততম সম্প্রসারণশীল নেটওয়ার্ক পরিণত হওয়া পর্যন্ত, কলকাতার মেট্রো ফের গর্বের বিষয় হয়ে উঠবে এটি। অমরকো মসুণ, উদযাপনকে সহজ এবং হৃদয়কে আনবে এবং কাছের করে তুলবে। মা দুর্গার আগমনের পাশাপাশি, পূজা অবশ্যেই যানজটের ছায়া ছাড়াই উদযাপন করা যাবে। মেট্রো মানুষকে উত্তর ও দক্ষিণ কলকাতার প্যাভেল-হপিংয়ে, কালাঘাট এবং প্রকল্পে প্রার্থীয়া এবং তাদের প্রিয়জনদের কাছে স্বাচ্ছন্দ্য এবং আনন্দের সাথে নিয়ে যাবে। প্রসঙ্গত, ১৯৮৪ সালে, যখন এই শহরে ভারতের প্রথম মেট্রো চলাচল করাছিল, তখন এটি কেবল একটি পরিবহন ব্যবস্থা ছিল না, এটি ছিল গর্বের মুহূর্ত। প্রজন্মের পর প্রজন্ম। এই গর্ব নিয়ে বেড়ে উঠেছে, মেট্রো তাদের দৈনন্দিন গল্পের অংশ হয়ে উঠতে দেখেছে। কিন্তু শহরটি যত প্রসারিত হচ্ছে, ততই একটি

বৃহত্তর, দ্রুত নেটওয়ার্কের স্বপ্ন প্রায়শই অসম্পূর্ণ বলে মনে হচ্ছে। রাস্তাঘাট ব্যস্ত হয়ে উঠেছে, যানজট আরও বেড়েছে। এই পুজোয়, মা দুর্গার আগমনের আগে সেই গল্প বদলে যাবে, প্রধানমন্ত্রী নরেন্দ্র মোদী কলকাতাকে ১৩.৬২ কিলোমিটার নতুন মেট্রো সংযোগ উৎসবের আগে উপহার দেবেন, যার মধ্যে তিনটি গুরুত্বপূর্ণ অংশ রয়েছে। গ্রিন লাইন (এসপ্ল্যান্ডে-শিয়ালদহ), ইয়েলো লাইন (নোয়াপাড়া-জয় হিন্দ বিমানবন্দর), আরেঞ্জ লাইন (হেমন্ত মুখোপাধ্যায়-বেলোঘাটা)। গ্রিন লাইন (এসপ্ল্যান্ডে-শিয়ালদহ) বাংলার দুটি লাইফলাইনকে আগের চেয়ে আরও কাছাকাছি নিয়ে আসবে। একসময় সড়ক পথে যাতায়াত করতে এক ঘণ্টা সময় লাগত এখন তা মাত্র ১১ মিনিট সময় নেবে। দৈনিক ছয় লক্ষেরও বেশি যাত্রীর জন্য, এটি জীবনের এক নতুন ছন্দ স্থাপন করবে। ইয়েলো লাইন (নোয়াপাড়া-জয় হিন্দ বিমানবন্দর) কলকাতাবাসীর দীর্ঘ দিনের লালিত স্বপ্ন পূরণ করবে। তা হল, বিমানবন্দরে সরাসরি মেট্রোর মাধ্যমে পৌঁছানো যাবে। এসপ্ল্যান্ডে থেকে নেতাজি সূভাষ চক্র বসু আন্তর্জাতিক বিমানবন্দরে যাত্রা, যা আগে সড়কপথে এক ঘণ্টা সময় লাগত, এখন মাত্র ৩০ মিনিট সময় নেবে।

পরিবারগুলি সময়মতো প্রিয়জনদের স্বাগত জানাবে, অমরকালীয়া কলকাতাকে আরও কাছে থেকে দেখতে পাবে এবং হাজার হাজার বিমানবন্দর কর্মী স্বাচ্ছন্দ্য এবং মর্যাদার সাথে ভ্রমণ করবে। আরেঞ্জ লাইন (হেমন্ত মুখোপাধ্যায়-বেলোঘাটা) সয়েদ সিটির মতো এলাকা এবং বেলোঘাটার কাছাকাছি বড় হাসপাতালগুলিকে সংযুক্ত করবে। রোগীরা স্বস্তি পাবেন, পরিবারগুলি আরাম পাবেন এবং শিক্ষার্থীরা নতুন সুযোগ খুঁজে পাবেন। শীঘ্রই, সন্টলেস সেক্টর ৫-এর আইটি হাবটিও এর সাথে সংযুক্ত হবে, যা পেশাদারদের দ্রুত এবং আরও নির্ভরযোগ্য ভ্রমণের সুযোগ করে দেবে। কলকাতা মেট্রোর বর্ধিত নেটওয়ার্ক শহরকে আগের চেয়ে আরও একত্রে সংযুক্ত করছে। উত্তরে নোয়াপাড়া এবং পূর্বে বেলোঘাটার মতো পার্শ্ববর্তী অঞ্চলগুলিকে এসপ্ল্যান্ডে, পার্ক স্ট্রিট এবং শিয়ালদহের মতো কেন্দ্রগুলির সাথে সংযুক্ত করে, মেট্রো লক্ষ বাসিন্দাকে বিভিন্ন অঞ্চলে আরও সুবিধাজনকভাবে প্রবেশের সুযোগ করে দিয়েছে। এটি দীর্ঘ যাতায়াতকে সহজ যাত্রায় পরিণত করছে, কাজ, পড়াশোনা এবং অবসরের জন্য নতুন সম্ভাবনা তৈরি করছে। সীমিত শহুরে পরিকাঠামো, ভারী বৃষ্টিপাত এবং

ক্রমবর্ধমান বায়বাহনের কারণে কলকাতা দীর্ঘদিন ধরে গুরুতর সড়ক যানজটের সাথে লড়াই করেছে। মেট্রো একটি দ্রুত এবং নির্ভরযোগ্য বিকল্প প্রদানের পাশাপাশি, সড়ক ভ্রমণের উপর শহরের নির্ভরতা হ্রাস পাচ্ছে। এটি কেবল শিয়ালদহ ফ্রিহুওভার, ইএম বাইপাস এবং বিমানবন্দর রোডের মতো এলাকায় যানজট কমিয়ে আনছে না বরং দৈনন্দিন যাত্রীদের জন্য দুশ্চর এবং চাপও কমিয়ে আনছে। মেট্রো কলকাতার অর্থনীতির চালিকাশক্তি হয়ে উঠেছে। এটি কর্মসংস্থান সৃষ্টি করেছে, দামামা, গড়িয়াহাট, পার্ক স্ট্রিট এবং এসপ্ল্যান্ডে মতো স্টেশনগুলির আশেপাশে স্থানীয় ব্যবসায়ীদের উৎসাহিত করেছে এবং সংযুক্ত এলাকায় শিল্পকে আকৃষ্ট করেছে। আরও যাত্রী, আরও দোকান এবং আরও সুযোগের সাথে, মেট্রো স্থানীয় অর্থনীতিকে উদ্দীপিত করছে। কলকাতাবাসীদের প্রতিদিন মূল্যবান ঘণ্টা বাঁচাতে সাহায্য করছে। উদাহরণস্বরূপ, এসপ্ল্যান্ডে এবং হাওড়া ময়দানের মধ্যে যাত্রা মাত্র ৫ মিনিটের মধ্যে সম্পন্ন হবে। দ্রুত ভ্রমণের অর্থ পরিবার, পড়াশোনা, কাজ এবং উদ্যোগের জন্য আরও বেশি সময় কলকাতা মেট্রো কেবল একটি স্বস্তির ব্যবস্থা নয়, এটি একটি লাইফলাইন যা অন্যদের সাথে সংযোগ স্থাপন করে।
