Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we are pleased to inform you that the Company has been awarded a **significant Work Order** for the **Computerization of additional 96 Primary Agricultural Credit Societies (PACS) (Illrd Phase)**, sanctioned by the **Government of India** in favour of the **State of Himachal Pradesh**.

The Work Order has been issued by the **Registrar of Cooperative Societies**, **Directorate of Cooperation**, **Himachal Pradesh**, and entails the implementation of comprehensive computerization activities across PACS located in all districts of the State of Himachal Pradesh

The total value of the Work Order is ₹1,67,71,200/- (Rupees One Crore Sixty-Seven Lakhs Seventy-One Thousand Two Hundred only), inclusive of all applicable taxes. The project is required to be completed within a stipulated period of 36 months.

This Work Order represents a further expansion of the Company's ongoing engagement in the PACS digitization initiative. Previously, the Company had been entrusted with the computerization of **863 PACS**, followed by an additional **919 PACS** in the State of Himachal Pradesh.
