**Sub.: Reg 34\_Non-submission of Annual Report 2024-25**

We hereby inform you that pursuant to our earlier intimations for holding of annual general meeting for the financial year 2024-25 dated 18.09.2025 and 27.11.2025, please take note that the Registrar of Companies – Mumbai, Maharashtra vide its letter dated 2<sup>nd</sup> December 2025, has granted an extension of 3 months from 30.09.2025 for holding of 29<sup>th</sup> Annual General Meeting of the Company for financial year 2024-25 i.e. on or before 31<sup>st</sup> December, 2025, in terms of the provisions of Section 96 of the Companies Act, 2013 which is enclosed herewith as “**Annexure A**”.

The Company, being part of the Future Group, which is facing tough times, has been facing liquidity issues due to adverse impact on its business operations which has made it difficult for the Company to meet its fund requirements for day to day expenses as well as to fund its statutory and regulatory payments. This has resulted in non-payment of fees/ charges payable to the Stock Exchanges, Depositories, Registrar and Share Transfer Agents (“RTA”) and other service providers for the Company. The Company is constantly discussing the fund requirements with its bankers in addition to making all efforts for generation of funds by monetising its assets as well. However, the requests made by the Company are till date not accepted by its bankers and monetisation efforts are also taking some time due to ongoing due diligence and negotiation by the willing purchasers. The Company is not in position to finalise its shareholders list in absence of the List of Beneficial Owners Report (more commonly known as “BENPOS data”) to be received from the depositories, which is not received due to non-payment of annual custodian fees to the Depositories NSDL and CDSL. Due to non-availability of the BENPOS from depositories to Registrar and Transfer Agent (RTA) and further discontinuation of support services by RTA due to non-payment of service charges to RTA, shareholders data, which is crucial for ascertaining eligible members to attend AGM, could not be finalised.

Accordingly, the Notice of the annual general meeting and Annual report is yet to be finalised and dispatched to the eligible shareholders which at present is becoming difficult to ascertain for the reasons mentioned above.
