Respected Sir/ Ma'am,

Pursuant to Regulation 30 read over with Para B (12) of Part A of Schedule III of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("LODR regulation"), Para B (12) of Part A of Annexure 18 of SEBI Circular no. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024, SEBI Circular No. SEBI/HO/CFD/CFD-PoD-2/P/CIR/2025/25 dated February 25, 2025 and Industry Standards on Regulation 30 of LODR Regulation, we hereby inform you, in continuation to our earlier letter number PML/BSE/BM/2024/183 dated November 13, 2024, whereby we had informed the Exchange regarding the Board's decision to re-commence the Money Transfer Service Scheme (MTSS) business by obtaining the required License from Reserve Bank of India, that the Company had applied to RBI for the said MTSS license vide its application dated November 06, 2025. The said application of the Company has now been rejected by RBI, without giving any opportunity of being heard and without citing any reason, vide their letter dated January 22, 2026.



The required details as per SEBI Circular no. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024 in this regard are as under:

However, there is no impact on existing Business of the Company as the same is conducted by the Company by virtue of AD- II License issued by RBI. The said license is the principal licensed held by the Company and the same has been duly renewed on January 21, 2026 by RBI and is valid till January 31, 2027.
D	Withdrawal/ cancellation or suspension of license / approval by the regulatory or licensing authority, with reasons for such action, estimated impact (monetary or otherwise) on the listed entity and penalty, if any	Not Applicable; as this was the fresh application being made for new line of business and the RBI has not cited any reason for not acceding to the request made by the Company. The Company shall be making a representation to the RBI in due course, and the outcome of the same shall be intimated to the Exchange at the appropriate time. The key license of the company is AD-II License which is duly valid and effective.
