Subject: Clarification /Confirmation on news item appearing in “Media/Publication”

This is with reference to the clarification sought by you, with regard to the news article titled “*IIFL Finance Q3 Results: Stock tanks 15% despite sharp surge in Gold loans; Here's why*” appearing in the <https://www.cnbctv18.com> dated January 22, 2026.

In this regard we would like to clarify as follows:

1. The Company confirms that, to the best of its knowledge, it is not aware of any information or event which has not been disclosed to the Stock Exchanges which could reasonably explain the aforesaid movement in the price of the Company's Equity Shares.
2. The financial results of the Company for the quarter and nine months ended December 31, 2025, were announced to the Stock Exchanges in compliance with applicable provisions of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, and the same are available in the public domain. The movement in the share price appears to be market sentiment driven or factors beyond the control of the Company.

With respect to your specific queries, we state as follows:

If so, you are advised to provide the said information along with the sequence of events in chronological order from the start of negotiations/ events till date - **No, there are no such negotiations/events, other than as disclosed in the Outcome of Board Meeting dated January 22, 2026.**
- b. Whether you/company are aware of any information that has not been announced to the Exchanges which could explain the movement in the trading, if any? Further, you are advised to provide the said information and the reasons for not disclosing the same to the Exchange earlier as required under regulation 30 of the SEBI (LODR) Regulations, 2015. - **Please refer to the para 1 and 2 above.**
- c. In case of regulatory/legal proceedings please provide the information on initiation / outcome of the proceedings - **There has been no initiation of any new regulatory or legal proceedings against the Company.**

The Company submits that there existed no material event, information or development as contemplated under Regulation 30 read with Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, which warranted disclosure to the Stock Exchanges.
