This is to inform you that, pursuant to the Composite Scheme of Arrangement approved by the Board of Directors of Tata Motors Limited and sanctioned by the Hon'ble National Company Law Tribunal, the Commercial Vehicles Business Undertaking of Tata Motors Limited has been demerged and vested into TML Commercial Vehicles Limited.

Further, consequent to the said Scheme:

- The name of Tata Motors Limited has been changed to Tata Motors Passenger Vehicles Limited, and
- The name of TML Commercial Vehicles Limited has been changed to Tata Motors Limited.

Upon the Scheme becoming effective, all assets, liabilities, rights, and investments pertaining to the Commercial Vehicles Business have stood transferred to and vested in the new Tata Motors Limited.

Accordingly, the shareholding of Automobile Corporation of Goa Limited ("ACGL") held by Tata Motors Passenger Vehicles Limited (formerly Tata Motors Limited), aggregating to 29,82,214 equity shares (representing 48.98% of the paid-up share capital of ACGL), has been transferred to the new Tata Motors Limited (formerly TML Commercial Vehicles Limited) pursuant to the said Scheme.
