Bengal sees sharpest rise in registered voters in border areas since 2002 SIR

RAVIK BHATTACHARYA Kolkata, November 21

BETWEEN 2002, WHEN the Special Intensive Review (SIR) was last conducted by the Election Commission of India, and 2025, West Bengal has seen a 66% increase in the number of registered voters – from 45.8 million to 76.3 million. Eighteen districts that comprised the state then, and ECI data shows that of the top 10 that showed the highest increase in the number of voters, nine districts border Bangladesh.

Different political parties in the state have different rationales for this — the opposition BJP says this is proof that "Muslim infiltrators" from Bangladesh are settling in India, while the ruling Trinamool Congress says it indicates the inflow from across the border of Hindu refugees escaping persecution.

The SIR is currently underway across the state's 23 districts (some larger districts

were carved into smaller ones between 2002 and now).

According to data available with the ECI, the nine districts on the border that have seen an uptick are: Uttar Dinajpur (105.49% increase in number of registered voters), Malda Murshidabad (94.58%),(87.65%), South-24 Parganas (83.30%), Jalpaiguri (82.3%), Cooch Behar (76.52%), North-24 Parganas (72.18%), Nadia

Bangladesh and settled in the border districts. The Hindu population in Bangladesh dropped from 23% (in 1951) to 8% (in 2022). They have not gone to China. Apart from small sections going to Assam and Tripura, the majority have come to West Bengal." He claimed there is a false

narrative being spread by the BJP of Muslim infiltration. "Such people have settled in Cooch Behar, Alipurduar and Bangaon, where the BJP has won with their votes... In Malda and Murshidabad, there is a sizable Muslim population, and we have won seats. However, our Chief Minister, Mamata Banerjee, does not believe in such religious divisions and is demanding protection for all," said Chakraborty.

Asked about Kolkata's relatively low uptick, Chakraborty said he isn't sure what explains the data.

Senior BJP leader and former state president Rahul Sinha called it an "alarming trend". "We have been saying this for years, and it's now being reflected in data. Seven districts bordering Bangladesh are in an alarming condition, and many are expected to become or will become Muslim-majority districts due to

infiltration," he alleged. "This infiltration and cre-

ation of hubs is being planned. That is why data shows an abnormally high percentage of voters as compared to 2002," he claimed. CPI(M) state president and

Politburo member, Md Salim, told The Indian Express that the inflow from Bangladesh is definitely a factor in the rise of numbers at the border districts. "BSF should have checked this. A sizable number of Hindu refugees also came in with others; that's why the Hindu population declined in the neighbouring country," he said. Regarding the low figures

of Kolkata, Salim said there are

various reasons. "Firstly, during the Left Front regime, we were able to develop small urban centres into towns. District towns were also developed. So people from villages did not directly come to Kolkata but went to these towns, like Barasat. We were able to develop rural areas. Secondly, I think a section of people have moved out of Kolkata... some may have settled in the suburbs too, if they haven't left the state. The birth rate (in Kolkata and the districts) is also a factor; it is not of a religious nature but due to backwardness."

IAMAI: Draft accessibility norms to impose cost burden on OTTs

IMPLEMENTATION OF PRO-POSED accessibility norms for

online curated content specifically for persons with hearing and visual impairment will lead to a high cost of compliance in several cases, which may even surpass their revenue and make them commercially unsustainable, industry body IAMAI said on Friday.

The information and broadcasting ministry in October floated draft accessibility standards for audio-visual content made available by publishers of online curated content (OTT platforms) to ensure that such content is accessible to persons with hearing and visual impairment. The focus of these guidelines is not only on the content but also on the information and other support needed by persons with disabil-

ities to enjoy such content. The Internet and Mobile Association of India (IAMAI) said that the proposed guidelines by the Ministry of Information and Broadcasting (MIB), could severely affect regional and smaller OTT platforms, owing to the extensive operational, technical, and financial obligations they are likely to impose.

Familiar crisis at COP30 as nations reject...

IN ORDER TO ensure that these issues do not become a roadblock to progress on the other items on the agenda, COP30 presidency Brazil had conducted several rounds of consultations on these difficult issues, and had planned a separate outcome document addressing each of these issues.

Two of the issues were dear to the developing countries including India, while the other two were being pushed largely by the developed world.

The four issues included the demand of the developing countries regarding full implementation of the finance provision contained in Article 9.1 of the Paris Agreement. These countries claimed that this particular provision had been ignored till now. Their other concern, voiced repeatedly by India and China, was related to trade measures like Carbon Border Adjustment Mechanism (CBAM) imposed by the European Union. These countries argued that CBAM was a unilateral and discriminatory trade practice disguised as climate action. The developed countries had been asking for raising of mitigation ambition in pursuance of the 1.5 degree Celsius target mentioned in the Paris Agreement. Their other issue related to greater transparency in reporting of climate actions.

Weaved into these four broad issues were demands for a road map on phase-out of fossil fuels and a tripling of adaptation finance.

The draft text that emerged on Friday addressed none of these issues in any concrete manner. It completely avoided any mention of fossil fuel phase-out, and proposed a two-year work programme on climate finance to discuss all matters related to finance, including Article 9.1, which was basically kicking the can further down the road.

On unilateral trade measures, the draft said that the countries agreed that responses to climate change must not constitute a means of "arbitrary or unjustifiable discrimination or a disguised restriction on international trade" and proposed further discussions on different platforms on this issue.

The draft political package was rejected almost immediately by the group that had been pushing for inclusion of a language on fossil fuel phase-out. Their representative Colombia called a press conference to announce that the draft package was unacceptable to it.

Colombian Environment Minister Irene Velez Torres told reporters that the problem was "the methodology of consensus". Any decision at COP meeting can only be arrived through consensus, which means noth ing is agreed till everyone agrees.

"The problem right now is this methodology of consensus, because this (process of) consensus has turned into a veto. And what is being left aside (as a result) is the ambitious agenda The most ambitious agenda has been eliminated. Veto is what is happening here,"Torres said.

A deadlock on the last day of the COP meeting is nothing unusual. In fact, it is a familiar setting at every COP meeting, as countries try to thrash out lastminute compromises to get to a final deal. In the process, the end decisions inevitably are extremely watered down versions of the demands that coun-

Like almost every other meeting before it, COP30 is also set to get extended, with negotiators expected to work through the night to come up with another draft that can be agreeable to everyone.

संपादकीय



नव्हे लोकशाहीचे मारेकर

चांगले शेजारी मिळणे हा अनेकजण आपल्या नशिबाचा भाग समजतात. म्हणूनच त्याला भारतात शेजारधर्म म्हटला गेला आहे. मात्र असा धर्म पाळण्यासाठी तितक्याच क्षमतेचा शेजारी लाभणे अत्यंत आवश्यक असते. जे व्यक्तीच्याबाबतीत अनिवार्य असते तितकेच एका राष्ट्राच्या किंवा देशाच्याबाबतीतसुद्धा अत्यंत महत्त्वाचे ठरते. दुर्दैवाने आज भारताला तसे सख्खे शेजारी देश लाभलेले नाहीत. त्यातले प्रामुख्याने पाकिस्तान आणि बांगलादेश हे दोन्ही भूप्रदेश एकेकाळी भारताचेच अविभाज्य अंग होते. त्यांनी त्यांच्या स्वार्थासाठी स्वतंत्र होण्याचा निर्णय घेतला. पण भारतासारख्या सर्वात मोठ्या लोकशाहीवादी देशाकडन कोणताही धडा घेतलेला दिसत नाही, उलट आपापल्या देशात लोकशाहीचे धिंडवडे काढत ते भारताला धडा शिकवण्याची अहंकारी भाषा वापरत असतात. केवळ हिंसाचार, दहशतवाद आणि कमालीचा धर्मांधपणा या दोन्ही देशांच्या नसानसात मुख्लेला आहे. स्वाभाविकपणे गेल्या साठ-सत्तर वर्षांत या दोन्ही देशांना आपला विकास साधता आलेला नाही. त्यांच्या या बुरसटलेल्या मानसिकतेचा बळी तिथली सामान्य जनताही ठरली आहे. कमालीची गरिबी, महागाई, बेरोजगारी, शिक्षण, आरोग्य या सर्व क्षेत्रामध्ये कमालीचा गलथानपणा अशी बजबजपुरी माजलेल्या या दोन्ही देशांमध्ये सगळ्या जगाने मान्य केलेली लोकशाहीची तत्त्वे सतत पायदळी तुडवली जातात. याची अगदी अलिकडची दोन प्रातिनिधिक उदाहरणे म्हणजे पाकिस्तानच्या लष्कर प्रमुखांना ज्यादा अधिकार देण्याचा स्वतंत्र कायदा पारित केला गेला म्हणजे तिथल्या संसदेपेक्षाही अनेक बाबतीत लष्कर प्रमुख हे वरचढ ठरतात. जी तरतूद लोकशाही कार्यपद्धतीच्या कोणत्याच निकषात बसत नाही. दुसरे उदाहरण बांगलादेशचे आहे. तिथल्या महिला राष्ट्राध्यक्षांना सळो की पत्नो करून सोडले गेले त्या आज भारतात आश्रय घेऊन राहत आहेत. स्वाभाविकपणे भारताने दाखवलेले हे स्त्री दाक्षिण्य तिथल्या धर्मांध, जिहादी आणि हिंसाचारी प्रवत्तींना मानवण्यापलिकडचे आहे. म्हणनच तिथल्या कोर्टाने शेख हिसना यांना थेट फाशीची शिक्षा सुनावली आहे.

भारतातला लोकशाहीचा सन्मान

या दोन्ही प्रातिनिधिक उदाहरणांमधून या दोन्ही देशांमध्ये लोकशाही नावाचा प्रकार औषधालाही उरलेला नाही. तिथल्या धर्मांधतेच्या हिंसाचाराने दहशतवादाचा राक्षस जन्माला घातला आहे. आणि त्यातूनच तिथे सातत्याने अस्थिरता असते. जाळपोळ, हत्याकांड, बॉम्बस्फोट हे तिथले इतके नित्याचे प्रकार झाले आहेत की, शांतता किंवा सर्वसामान्य माणसाचे जनजीवन स्वस्थ आणि सुरक्षित राहण्याची सूतराम शक्यता उरलेली नाही. सततची अस्थिरता तिथल्या समाजव्यवस्थेला कोणत्याच प्रकारचे स्वास्थ्य लाभू देत नाही. ज्यांच्याकडे पैसा आहे, अधिकार आहे, दहशत किंवा हिंसाचार करून आपला प्रभाव टिकवण्याची क्षमता आहे, असे लोकच आर्थिकदृष्ट्या सुस्थितीत पाहायला मिळतात. बाकी अन्य सगळा सर्व उ समाज आहे त्या परिस्थितीत समाधान मानून घेताना दिसतो. एका अर्थी त्या देशांसाठी ही मोठी शोकांतिका

ठरते. ज्या भारतापासून आपण विलग झालेलो आहोत त्या शेजारी देशाने सगळ्या जगाला लोकशाही मूल्यांचा किंबहुना संसदीय लोकशाही व्यवस्थेचा आदर्श घालून दिला. संविधानाच्या माध्यमातून सर्वसामान्य माणसाचे अधिकार अबाधित ठेवले जातात. निवडणुका किंवा मतदानाच्या प्रक्रियेतून अतिशय शांततेने लोकनियुक्त सरकार निवडले जाते. जगातला सर्वाधिक लोकसंख्येचा देश आणि तिथे पार पडणारी संसदीय लोकशाहीतली निवडणूक प्रक्रिया हा जागतिक विक्रम ठरतो. या सगळ्या प्रक्रियेचे व्यवस्थापन निवडणूक आयोगाकडून काटेकोरपणे पाळले जाते. अगदी वीस-पंचवीस वर्षांपर्वी ज्या बिहारमध्ये एकही निवडणूक शांततेने होत नव्हती. मतदान केंद्र बळकावण्यापासून ते मतपेट्या पळवून नेण्यापर्यंतचे अनेक प्रकार व्हायचे. त्या बिहारमध्ये यावेळच्या विधानसभा निवडणुकीत एकही गैरप्रकार घडला नाही. एकाही ठिकाणी पुनर्मतदानाची किंवा पुनर्मतमोजणीची वेळ आली नाही. कोणताही गैरप्रकार ु किंवा हिंसाचारही घडला नाही. संसदीय लोकशाहीची ताकद कशा स्वरूपाची असते याचे हे अगदी ताजे उदाहरण ठरते. भारताने सर्वसामान्यांच्या अधिकाराच्या संरक्षणासाठी आणि देशाचे सार्वभौमत्व अबाधित राहण्यासाठी ही संसदीय लोकशाही पद्धत निवडली. आणि ती कमालीची यशस्वी ठरली आहे.

शत्रुत्व हेच त्यांचे अस्तित्व

भारतातली ही संसदीय लोकशाही व्यवस्था एक वैभवशाली परंपरा ठरली आहे. निदान याचे तरी भान ठेवन श्रेजारी राष्टांनी भारताच्या मदतीने स्वतःचा विकास साधुन घेण्याची तयारी दाखवायला हवी होती परंतु केवळ भारताविरुद्धची असूया, मत्सर, शत्रूत्व असा एकमेव अजेंडा राबवून हे दोन्ही देश सातत्याने स्वतःचे नुकसान करून घेत आहेत. ज्या बांगलादेशात न्यायव्यवस्थेचीसद्धा लक्तरे वेशीवर टांगली गेली आणि आपल्या महिला अध्यक्षाला फाणीची णिक्षा सुनावून तिथे लोकशाही व्यवस्थेचेच दफन केले गेले पाकिस्तानमध्ये तिथले राष्ट्राध्यक्ष राहिलेल्या झुल्फिकार भुत्तोंना फाशी दिले गेले होते. त्यांचीच मुलगी बेनेझिर . भुत्तो बॉबस्फोटामध्ये मृत्युमुखी पडली होती. आणि आता तिथला माजी पंतप्रधान इम्रान खान गेली दोन वर्षे कारागृहात आहे. अशा परिस्थितीत तिथल्या लष्कर प्रमुखाला ज्यादा अधिकार देण्याचा प्रकार म्हणजे सगळ्या देशाला पुन्हा एकदा अराजकतेत ढकलण्याचा प्रकार ठरतो. म्हणूनच हे दोन्ही देश भारताचे शेजारी असूनही लोकशाहीचे कट्टर मारेकरी ठरतात. आतापर्यंत भारताने पाळलेला शेजारधर्मदेखील यांना निभावता आलेला नाही. पाकिस्तानला वेळोवेळी केलेली मदत असेल किंवा अगदी बांगलादेशची निर्मिती असेल याचे कोणतेही भान न ठेवता केवळ धर्मांधता आणि हिंसाचार दहशतवादातून किंबहुना भारताबरोबरच्या शत्रूत्वातून आपले अस्तित्व टिकवण्याचा या दोन्ही देशांचा खटाटोप सुरू असतो. अगदी नोबेल पारितोषिक मिळवण्याइतकी पात्रता आज तिथले हंगामी अध्यक्ष युनूस यांच्याकडे असली तरी ती आज धर्मांधतेत गहाण पडलेली आहे.

१२ धावांमध्ये इंग्लंडने पाच विकेट गमावल्या आणि इंग्लंडचा संघ १७२ धावांवर सर्वबाद झाला.
