**Subject: Update on Disclosure under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015**

We refer to our intimation dated September 30, 2025, wherein the Company had informed stock exchanges regarding the receipt of an order from Additional Commissioner, CGST & Central Excise, Palghar Commissionerate ('the impugned order'), confirming GST demand of ₹ 17,288,610,803/-, levying a penalty of ₹ 1,728,861,079/- and Interest u/s 50 of CGST Act, 2017 for the period July 2017 to March 2022, covering various States where the Company was registered during this period. Subsequently, the Company had filed a Writ Petition before Hon'ble Bombay High Court ("Hon'ble Court") against the impugned order. The impugned order refers to matters, which are relating to industry wide issues and pertains to taxability of co-insurance premium received as follower and re-insurance commission.

We wish to inform you that the Company has received a communication from its tax advisors on January 22, 2026 at 3:04 p.m. regarding the interim order passed by the Hon'ble Court providing an ad-interim stay to the impugned order.
