Rlys to receive 2 prototype non-AC EMU rakes with automatic doors

THE CENTRAL Railway is set to receive two new non-AC Electric Multiple Unit (EMU) rakes equipped with automatic doors and vestibules from the Integral Coach Factory (ICF), Chennai, by the end of March 2026. The rakes are expected to be introduced on the suburban network from April 2026, following a series of trials.

The rakes were developed following the Mumbra local train accident on June 9, 2025, in which four passengers were killed and several others injured. The accident occurred when commuters, many travelling on footboards or hanging onto open doors, fell as two trains passed each other near Mumbra station in Thane district. The incident highlighted safety risks associated with overcrowded non-AC suburban trains operating with open doors during peak hours.

In response, Union Railway Minister Ashwini Vaishnaw directed ICF to design rakes prioritising passenger safety. The prototype features automatic door-closing mechanisms to prevent passengers from leaning out or boarding moving trains, ventilated door louvres and roof-mounted fans to maintain airflow, and vestibules between coaches to allow passengers to move safely and redistribute crowds during peak hours.

“The ICF will deliver the prototype by the end of March and after that Central Railway will conduct multiple trials on the prototype to come to a conclusion,” said Swapnil Nila, Chief Public Relations Officer, Central Railway.

The rakes were ordered shortly after the Mumbra accident and are expected to undergo comprehensive testing before being deployed in revenue service. Once approved, they will mark a significant safety upgrade for the Central Railway suburban network, which carries more than 70 lakh passengers daily.

HC restrains Kumar Sanu's former wife from making defamatory comments

IN AN interim relief to playback singer Kumar Sanu, the Bombay High Court on Wednesday restrained his ex-wife Rita Bhat-tacharya or her representatives from posting, sharing or circulating any defamatory content about the singer and his family through any medium.

The court said that the ex-wife “immediately restrain herself and ensure that there is no further reputational damage caused any further and no further insinuations are spoken by her about/against the plaintiff Sanu”.

The HC passed an interim order while hearing an interim application by the singer in his Rs 30 lakh defamation suit against his ex-wife for allegedly making defamatory statements through interviews given to entertainment platforms.

“Prima facie, after going through the same, I am of the opinion that at some places in the interviews which have been given by Defendant, there is clear personal tirade against Plaintiff which is prima facie qualified by words that are used there,” a single-judge bench observed.

Retd Army Col alleges assault by son-in-law

Mumbai: A retired Army colonel has lodged a complaint against his son-in-law, accusing him of assaulting him and snatching his mobile phone in Mumbai's Bandra area, police said on Thursday.

The incident took place on Wednesday evening on the premises of St Andrews College, they said. Amrit Pal Singh, 63, a resident of Mohali in Punjab, made the allegations against his son-in-law, Sarthak Zohar. ENS

HC notice to state after UK doctor detained over social media posts against BJP

THE BOMBAY High Court on Thursday issued notice to the state government and other respondents seeking their reply to a plea by a UK doctor and YouTuber Sangram Patil seeking to quash an FIR against him for alleged objectionable social media posts against BJP leaders. A British national of Indian origin, Patil also alleged that the Look Out Circular (LOC) issued against him by the Mumbai police was illegal.

A single-judge bench of Justice Ashwin D Bhobe issued notice to the respondents and posted the next hearing to February 4. Senior advocate Sudeep Pasbola, representing Patil, submitted that there was urgency in the matter. His client had come to India from the UK on his own and was unaware of the FIR registered against him, he added.

Advocate General Milind Sathe for the state government said that Patil “seems to be connected with the other post and he seems to be not cooperating” with the agency. Sathe stated that a reply to the plea, if any,

will be filed within a week, which the court accepted.

Patil's plea sought directions from the court to quash and set aside the FIR registered by Mumbai Police. It also sought a stay on further probe, protection from coercive action pending hearing of the matter. The plea also urged for quashing of the LOC issued against Patil, which prevented him from travelling to the UK, along with removal of the petitioner's name from the authorities' database. The plea further prayed for directions to the respondents not to file a charge-sheet against Patil during the pendency of his petition.

Patil in his plea said the FIR "does not allege any incitement to violence, threat to public

order, or disturbance of public tranquility”.

The plea also said the FIR "does not specify the group of religious, racial, language or regional groups or caste or communities in which hatred or ill will is promoted by the post.” Advocate Ujjwalkumar Chavhan, who filed a plea for Patil stated that the police had “mechanically” registered FIR without any preliminary enquiry and non-application of mind, therefore “misusing the powers”.

The plea also said that “within a few days of registration of FIR, without further inquiry, LOC was issued.” The action was “absolutely arbitrary,” the plea said. “There was a malicious act of the police officers who initiated the proposal of issuance of LOC till the highest level in the hierarchy who had approved the issuance of LOC,” it added.

The Mumbai Police detained Patil on January 10 on his arrival at the Mumbai international airport. He was later prevented from leaving the UK on January 19. On January 21, he recorded his statement before the police.
