As you are aware, Navin Fluorine International Limited ('the Company') has paid Final Dividend of ₹ 7/- (INR Seven only) per equity share of the face value of ₹ 2/- each for the Financial Year 2024-25 on August 08, 2025 as recommended by the Board of Directors of the Company at its Meeting held on May 09, 2025 and declared at the 27th Annual General Meeting held on July 31, 2025.
