SYNOPSIS

1. Skyline Ventures India Limited (hereinafter referred to as the “Corporate Debtor”) is a Company incorporated under the Companies Act, 1956 on 17/12/1988, having its registered office at Workafella, Cyber Crown-424, Sec-II, HUDA Techno Enclave, Madhapur, Hyderabad, Telangana – 500081.

2. The primary business activities of the Corporate Debtor is energy sector and the construction of buildings and providing of IT-related services.

3. The Corporate Debtor approached the Financial Creditor, Raj Breeders & Hatcheries (P) Ltd., for a short-term loan of Rs. 1,50,00,000/- (Rupees One Crore and For Raj Breeders And Hatcheries Pvt. Ltd.

Fifty Lakh only) by way of Inter-Corporate Deposits (ICDs) to meet its immediate business and operational requirements. Relying on the representations and undertakings of the Corporate Debtor, the Financial Creditor agreed to extend the ICD on mutually agreed terms. An ICD Agreement was executed between the parties on 08/10/2025, outlining the terms and conditions of the transaction. Both parties expressly confirmed that they are not related parties and that this transaction does not constitute a deposit under Section 2(31) of the Companies Act, 2013. Copy of the ICD Agreement is enclosed as **Annexure I**.

4. The Financial Creditor disbursed the loan in the following manner: first instalment of Rs. 50,00,000/- on 08/10/2025, second instalment of Rs. 64,00,000/- on 09/10/2025, and third instalment of Rs. 36,00,000/- on 10/10/2025, aggregating to Rs. 1,50,00,000/-. Subsequently, upon an oral request by the Corporate Debtor, an additional sum of Rs. 28,00,000/- was advanced on 17.10.2025, bringing the total loan amount to Rs. 1,78,00,000/- (Rupees One Crore Seventy Eight lakh only). The disbursals were made to the Corporate Debtor by way of transfer of funds to the Current Account No.99988817111988 maintained with Hitech City Branch of HDFC Bank, Hyderabad. As per clause 1.1 of the ICD Agreement, the tenure of the ICD is 12 months from the date of disbursement. Clause 6.2 stipulates that the entire outstanding principal and interest shall become immediately due and payable upon occurrence of an event of default. Clause 6.1 defines certain events constituting default, including any change in the ownership, management, or control of the Corporate Debtor. Statement of Account of Corporate Debtor in the books of Applicant is enclosed as **Annexure II**. Statement of Account of Applicant in the books of Corporate Debtor is enclosed as **Annexure III**.

5. It has come to the notice of the Applicant that Ms. Asha Mitta, Managing Director tendered her resignation on 22/10/2025 with immediate effect. A copy of the resignation letter is enclosed as **Annexure IV**.

6. The resignation of Ms. Asha Mitta constitutes a change in the management and control of the Corporate Debtor, thereby triggering an event of default as per clause 6.1 of the ICD Agreement.

7. It has further come to the notice of the Applicant that a resolutions is being moved to remove some more existing directors and to induct new directors in their place, by calling an Extra-ordinary General Meeting, by shareholders having voting rights to the extent of more than 10% under Sec 100 of the Companies Act, 2013.

8. In light of the aforementioned change in management as mentioned in para no.6 above, the entire outstanding principal and interest became immediately due and payable, in accordance with clause 6.2 of the ICD Agreement.

9. Consequently, the Applicant issued a notice to the Corporate Debtor on 28/10/2025, demanding payment of the entire outstanding principal along with accrued interest within seven (7) days from the date of receipt of the said notice. The notice was duly served by hand on 28/10/2025, and acknowledgement was obtained. Copy of the notice enclosed as **Annexure V**.

10. The seven days' time given for repayment ended on 04/11/2025. However, no repayment was received from the Corporate Debtor as on 07/11/2025.

11. The default, therefore, occurred on 04/11/2025.

12. As on 7.11.2025, the total outstanding amount due from the Corporate Debtor stands at Rs. 1,79,68,658/- (comprising principal of Rs. 1,78,00,000/- and interest of Rs. 1,68,658/-), which remains unpaid to the Applicant Financial Creditor. A detailed computation of the outstanding dues is annexed to Application in Form 1.

13. The Corporate Debtor has wilfully defaulted in repayment of the outstanding dues and has disregarded the demand made by the Applicant, thereby demonstrating an intention to evade its financial obligations.

14. In view of the above stated default in repayment by the Corporate Debtor, the Applicant Financial Creditor is constrained to file the present application under Section 7 of the Insolvency and Bankruptcy Code, 2016, read with Rule 4 of the Insolvency and Bankruptcy (Application to Adjudicating Authority) Rules, 2016, in Form I, praying for orders for initiation of Corporate Insolvency Resolution Process (CIRP) against the Corporate Debtor.






