## PEACE OVERTURE | US prez meets his Ukrainian counterpart Zelenskyy before holding talks with Russian leader Putin

## War has to end: Trump

DAVOS

US President Donald Trump on Thursday said he had a good meeting with Ukrainian President Volodymyr Zelenskyy, and his message to Russian President Vladimir Putin



is that "war has to end." Replying to media queries before leaving Davos, Trump said a US delegation will be meeting Putin today or tomorrow.

"I met President Zelenskyy here: the meeting was good. We (US delegation) are meeting President Putin today or tomorrow," he said.

Later, Zelenskyy said he has a positive meeting with Trump.

"The meeting was good and it was in favour of our country," Zelenskyy said in Davos after his special address at the WEF Annual Meeting.

"As any President, I have to defend the interest of my country and such interests are generally difficult. But, yes, today it was positive."

He said the US delegation will also meet a Ukrainian team separately, in addition to their meeting with Putin and also a trilateral meeting between the US, Russia and Ukraine.

## Sovereignty not negotiable: Denmark PM

Copenhagen: Denmark's PM insisted her country cannot negotiate on its sovereignty on Thursday after US President Trump said he agreed on a "framework of a future deal" on Arctic security with the Nato head. Trump said the outcome would be "all the military access we want" to Greenland.

Danish Prime Minister Mette Frederiksen said security in the Arctic is a matter for all of Nato, and it is "good and natural" that it be discussed between the US president and Nato chief Mark Rutte. She had spoken to Rutte "on an ongoing basis", including before and after he met Trump in Davos.

She wrote Nato was fully aware of the kingdom of Denmark's position that anything political can be negotiated on, including security, investment and economic issues — "but we cannot negotiate on our sovereignty."

## The UAE will host first trilateral talks on the Ukraine war with the US, Russia and Kyiv on Friday, says Zelenskyy.

Asked what would be his message to Putin, Trump said,

"The war has to end. A lot of people have been killed. Last month, around 30,000 people were killed, mostly soldiers. It's really a war that has to end."

"We have got to get it done. If we don't get it done, it will be a disgrace," Trump said.

His special envoy Steve Witkoff was expected to travel to Moscow later in the day to meet Putin and discuss plans to end the war.

Further, a Ukrainian attack on port facilities in Russia's Krasnodar killed three people.

Meanwhile, the German government announced the expulsion of a Russian diplomat over a case in which a woman was arrested on suspicion of supplying information related to the war in Ukraine to an intelligence contact at Moscow's embassy in Berlin. —PTI

## 3 killed in Oz shooting

When Australia's PM Anthony Albanese was apologising for his government's failure to prevent the Bondi attack, three people died and another sustained injuries in a shooting in New South Wales.

Flags were flown at half-mast as the country observed a memorial event at Sydney's iconic Opera House, titled "Light Will Win".



"You came to celebrate a festival of light and freedom and you left with the violence of hatred. I am deeply and profoundly sorry we could not protect your loved ones from this evil," Albanese said in his speech to the relatives of the Bondi attack deceased.

A minute's silence, including on the TV channels, was held across the nation after 7 pm in Sydney as the memorial began. Attendees lit candles and heard speeches from lawmakers, and Jewish prayers and video tributes.

Buildings, including cricket stadiums in Melbourne and Perth, were illuminated, while play was paused during the Australian Open tennis tournament to observe the silence.
