This is to inform that I, the undersigned Prasanna Shirke, hereby tender my resignation from the post of CFO for the reason of getting better business opportunities.

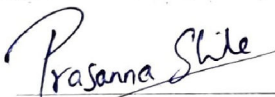
I request to the Board to accept my resignation and relieve me from my duty and responsibility with immediate effect.
