I, submit my report as under:

- The e-voting period remained open from 9.00 a.m., Monday, 18th September, 2017 to 5.00 p.m., Wednesday, 20th September, 2017. At the end of the remote e-voting period, the facility was blocked by the Service Provider.
- At the venue of the AGM, the empty Ballot Box kept for voting through Polling Process was locked in my presence and members who were present at the meeting. The locked Ballot Box upon completion of the voting was unblocked in my presence. After the conclusion of the counting of votes through Polling Papers, the votes cast through remote e-voting were unblocked in presence of 2 witnesses Miss. Sayanti Bagchi and Mr. Sanjoy Dey who are not in the employment of the Company. The result of remote e-voting are based on the reports generated from Service Provided website www.evotingindia.com.
- We have collated the votes downloaded from the remote e-voting and poll to declare the final results for each of the resolution forming part of the AGM Notice and to ascertain the number of shares voted in "Favour" or "Against". The members who have abstained from the aforesaid voting process have not been considered in preparation of the Consolidated Report. The polling papers which were incomplete and/or which were otherwise found defective have been treated as invalid and kept separately.
