In this regard, we wish to submit that, as already disclosed in the aforesaid corporate announcement, a **Search and Seizure action under Section 132 of the Income Tax Act, 1961** was conducted on **15.12.2025** in the case of **M/s Rathi Bars Limited (CIN: L74899DL1993PLC054781)** and its Directors, namely:

- Mr. Uddhav Rathi (DIN: 06604905)
