Dear Sir / Madam,

In terms of Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 and in reference to our earlier intimation dated 12<sup>th</sup> November, 2025 submitted to the stock exchanges (copy attached), wherein Ministry of Human Resources and Emiratization, UAE (the “**Authority**”) imposed a penalty of AED 284,000 (~INR 68.48 lakhs) on the branch office of the Company situated in United Arab Emirates on account of alleged non-compliances pertaining to Emiratization and the waiver application filed by the branch office of the Company, this is to further update that the branch office was in process of submitting voluminous records required for waiver besides following the lengthy procedural requirements to satisfy compliance with Emiratization. However, since the Authority is not issuing new work visas, the branch office has decided to discharge the penalty to ensure reactivation of the Company's profile on the Authority's portal and seamless issue of new work visas. The penalty was discharged on 22<sup>nd</sup> December, 2025 at about 06:05 p.m. (IST).
