Pursuant to Regulation 30 read with Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations") and the SEBI Master Circular SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024, we inform that the Company has received a favourable order dated 16 December 2025 from the Hon'ble High Court of Kerala at Ernakulam in the matter of IA No. 1 of 2025 in WA No. 599 of 2020, filed against the State of Kerala, Forest & Wildlife Department, the Conservator of Forests, Thrissur, and others. (copy uploaded on 19 December 2025)

The Hon'ble Court has permitted the Company to cut, remove, and replant rubber trees and has recalled its earlier direction requiring deposit of entire sale proceeds with the Forest Department. The Court has further directed quarterly submission of statement of accounts to the Forest Department and permitted Forest officials to oversee the cutting, removal, and replanting activities.

The aforesaid order is expected to have a favourable impact on the operations and financial position of the Company.
