Dear Sir / Madam,

- 1. In terms of Regulation of 30 of the SEBI (LODR), we wish to inform that on 17 Apr 2018, a 'Near Cyclonic Storm' hit Kolkata, and the entire structure of the 250 Ton Goliath Crane collapsed, resulting in damage to the Module Hall, New Dry Dock, Inclined Berth and a part of the Stores Complex located in the Main Works Unit of the Shipyard. All the assets of the Shipyard damaged during the incident were insured with M/s. Reliance General Insurance Company. The book value of the assets damaged is ₹107.40 crore.
- 2. The Insurance Surveyors have admitted a claim of ₹112.69 crore out of which ₹96.76 crore against Assets/Inventory of the Company whose book value is ₹107.40 crore. Hence, there is a loss on Insurance Claim for ₹10.61 crore that has been booked to the Statement of Profit & Loss Account under the head "Exceptional Items" in FY 2019-20.
- 3. The balance amount of ₹15.91 crore has been admitted against damaged module hall which was built from the funds allocated by Indian Navy and this assets was not appearing in the Books of Accounts of the Company. The Company being the custodian of these assets had taken insurance coverage.
- 4. The admitted claim amount of ₹112.69 crore has been received from the Insurer in two trenches on 22 Jun 2020 and 23 Jun 2020.
- 5. This is for your information and record.
