Dear Sir/Madam,

Pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform you that the Adjudicating Officer / Additional District Magistrate (Pr.), Gautam Buddha Nagar, Uttar Pradesh, has imposed a penalty of ₹10 lakhs on the Company under Sections 51 and 52 of the Food Safety and Standards Act, 2006, pertaining to a matter during 2018. On 15 February 2018, the Designated Officers of the Department of Food Safety and Drug Administration, Gautam Buddha Nagar had collected a sample of "Heritage Fresh Paneer – 200 gm" from M/s Reliance Fresh Ltd., Beta-1, Main Market, Greater Noida, Gautam Buddha Nagar and found that the Milk Fat content of the sample was less than minimum prescribed limit of 50 % for Paneer and that the Lot number & Packing date was not declared on the packet.

The Company is of the view that it has a strong case on merits to appeal the order. The company has taken appropriate legal advice and is in the process of filing an appeal against the said Order.
