This is further to our disclosure dated 14th August 2023, intimating ongoing income-tax dispute on account of various disallowances in the assessment order for AY 2016-17. The dispute was pending adjudication at first appellate level i.e. Commissioner of Income-tax (Appeals) "CIT(A)".

Pursuant to provisions of Regulation 30(7) read with sub-para 8 of Para B of Part A of Schedule III of SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), as amended, this is to inform that CIT(A), vide order dated 23 October 2025, has disposed of the matter by partly allowing the appeal.

Through the appellate order, relief amounting to Rs. 1,102.91 crores have been obtained on account of issues decided in favour of the Corporation, as against contested disputed tax and interest of Rs. 1,194.07 crores. The Corporation will be contesting the balance disputed tax of Rs. 91.16 crores before the higher forum i.e. Income-tax Appellate Tribunal.
