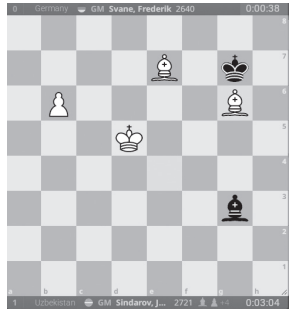

Madurai celebrates arrival of junior hockey trophy tour

Madurai, Nov 15: The Junior Hockey World Cup trophy, ahead of the tournament scheduled to be held in Madurai and Chennai until December 12, received an enthusiastic welcome in Madurai on Friday. The glittering trophy, which will be awarded to the winning team, was brought from Chennai and reached Madurai via Ramanathapuram and Sivagangai.

On Thursday morning, the trophy was taken in a ceremonial procession from the Race Course Stadium. At 9:00 a.m., it was displayed for the public on a special stage near the Amman Sannidhi of the Meenakshi Amman Temple, drawing a large crowd of devotees, students and sports enthusiasts.

Ministers Murthy and Thiagarajan participated in the event and flagged off the procession. Officials and sports representatives accompanied the trophy throughout its route.

From the temple, the procession moved through Vilakkuthoon, Teppakulam, Kuruvikkaran Salai, Aavin Junction, Wafk Board College and Annanagar arch, finally returning to the Race Course Stadium around 11:30 a.m. The streets were lined with spectators cheering and taking photos as the trophy passed by.

Students, sportspersons from local clubs and the general public gathered in large numbers along the route to celebrate the arrival of the prestigious World Cup trophy. Many expressed pride in Madurai hosting a major international sports event.

The event was jointly organized by the



Sports Development Authority of Tamil Nadu. Senior Regional Manager Velmurugan, District Sports Officer Raja and Hostel Manager Murugan coordinated the arrangements, ensuring a smooth and vibrant public display.

Ethirajan clinches singles title in Masters TT

Salem, Nov 15: Chennai's R. Ethirajan delivered a dominating all-round performance to emerge Singles Winner at the 3rd Masters State Ranking Table Tennis Tournament held in Salem on Sunday.

Ethirajan remained unbeaten throughout the league stage, securing the No.1 rank in



his group with emphatic victories. He defeated Janakaraju (Madurai) 11-3, 11-2, 11-4; Suresh Kumar (Coimbatore) 11-5, 11-3, 11-9; Venkatraman (Madurai) 11-1, 11-4, 11-7; and Suresh Kasiraj (Tiruchi) 11-4, 11-6, 11-3.

Carrying his momentum into the knockout rounds, Ethirajan beat Suresh Kumar (Madurai) 11-3, 11-8, 11-5 in the quarterfinals, and followed it up with a commanding 3-0 win (11-6, 11-7, 11-9) against Baskaran (ONGC) in the semifinals.

In the final, Ethirajan showcased excellent control and consistency to defeat Debajeet (Maharashtra) in straight games 11-6, 12-10, 11-8, sealing the title without dropping a single set in the entire tournament.
