a) Issue and allotment of 8,79,29,651 Equity Shares to 14 eligible qualified institutional buyers at the issue price of ₹ 62.55/- per Equity Share (including a premium of ₹61.55/- per Equity Share), (which included a discount of Rs. 3.29 i.e. 5% to the floor price of ₹65.84) aggregating to approximately ₹550 Crores (Rupees Five Hundred Fifty Crores) pursuant to the Issue in accordance with the provisions of the SEBI ICDR Regulations.
