This is in continuation of our earlier communication dated August 14, 2023 containing disclosures under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (SEBI Listing Regulations) read with Schedule III, Part-A, Para B (Clause 8) pertaining to pending litigation(s) or dispute(s).

We wish to inform you that Principal Commissioner of Central Goods and Service Tax has passed an order dated November 27, 2025 and re-affirmed the existing tax demand of Rs. 23,58,82,562/- (including all applicable cesses) along with the penalty of Rs. 23,58,92,562/-.

Further to this, an appeal will be filed against the demand order before the Appellate Tribunal (i.e. CESTAT). Please note that there is no Change in the previously disclosed tax demand amount, the adjudicating authority has merely reaffirmed the earlier position. There is no material impact on financial, no impact on operation or other activities of the Company due to this Assessment Order.
