We would like to inform that pursuant to SEBI (Prohibition of Insider Trading) Regulations, 2015 as amended from time to time and read with BSE Circular No. **LIST/COMP/01/2019-20 dated 2nd April, 2019**, the window for trading in the shares of the Company shall remain closed from **Thursday, 1st day of January, 2026 till completion of 48 hours after the declaration of the Standalone and Consolidated Un-Audited Financial Results of the Company for the quarter/nine months ended 31st December, 2025.**

Pursuant to SEBI circular No. **SEBI/HO/ISD/ISD-PoD-2/P/CIR/2023/124 dated 19th July, 2023**, company is required to give prior intimation to designated depository appointed by the company i.e. CDSL atleast 2 (Two) trading days prior to commencement of the trading window closure through online mechanism.

All the Promoter and Promoter group, Directors, KMP's, Designated Persons/Employees, Connected Persons of the Company and their immediate relatives are advised not to deal in the shares of the Company either directly or indirectly during the aforesaid period and the PAN will be freezed by the CDSL specifically for company's share.
