Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI LODR Regulations"), we hereby inform you that the Board of Directors of **HT Music and Entertainment Company Limited** ("HTME"), a wholly owned subsidiary of the Company, has on **25<sup>th</sup> November, 2025** decided to surrender the License issued by the Ministry of Information and Broadcasting (MIB), Govt of India for operating FM Radio Station titled 'Fever' in Chennai.

In this regard, HTME has submitted an application to the MIB on 25<sup>th</sup> November, 2025. Consequently, the operations of the said station shall be closed w.e.f. 24<sup>th</sup> December, 2025.

We further inform you that Next Radio Limited, a subsidiary of the Company, had earlier surrendered its License to operate a radio station in Chennai with effect from 24<sup>th</sup> October, 2025.
