Pursuant to the said order, the tax demand will be reduced to NIL for the AY 2013-14 to AY 2015-16 and AY 2017-18.

(IST). Pursuant to the said OGE, the tax demand of Rs. 81.53 crores for the AY 2019-20 has been set aside and the Company is eligible for refund of Rs. 7.35 crores.
