1 Company does not have any subsidiary.

2 Related parties as defined under para 9 of Ind AS 24 'Related Party Disclosures' have been identified based on representations made by key managerial personnel and information available with the Company.

3 Amount in bracket denotes credit balance / Liability.

4 During the period, the company has not made any investment/disinvestment in group companies / associates. Change in value of investment in group company represents effect of change in their fair value as per requirement of applicable Indian Accounting Standards (Ind AS).

5 The disclosures of Related party transactions as above are identified based on PAN of the related parties available on record of the Company.

6 Amount of Trade receivable and Trade payable represents gross value of securities purchased & sold through Four Dimensions Securities (India) Limited being Share broker through whom trade was executed, which includes brokerage payable to Four Dimensions Securities India Limited for availing its broking services.

7 Value of transaction during the reporting period for "Loan given" is summation of Loans disbursed at various point of time to related parties under revolving Loan facility with in the sanctioned Limit during the period . However at any point of time outstanding Loan amount did not exceed sanctioned Limit.

8 Value of transaction during the reporting period for "Loan taken" is summation of Loan Borrowed at various point of time from related parties under revolving Loan facility with in the sanctioned Limit during the period . However at any point of time outstanding Loan amount did not exceed sanctioned Limit.

9 The Company has made investment of Rs. 500,00,000 (50,00,000 shares of Rs. 10 each) 8% non-cumulative, non-convertible, redeemable Preference shares issued by Urudavan Investment & Trading Private Limited during financial year 2019-20. This investment is measured at fair value through profit & loss account. The amounts mentioned in Opening & closing balance are values of preference share after applicable Ind AS adjustments.

10 Amounts less than Rs.500/- (Five Hundred rupees) are denoted as "0.00".
