In consideration of regulation 15 (2)(b) of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, We would like to confirm that the provisions as specified in Regulation 23(9) shall not apply owing to the exemption criteria i.e.
