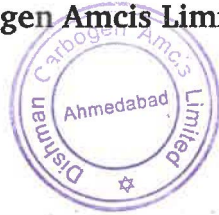

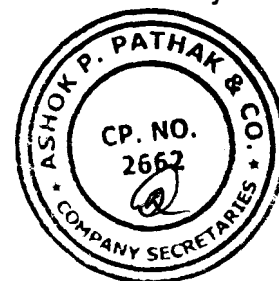
Dear Sir,

Pursuant to the resolution passed by the Board of Directors of **Dishman Carbogen Amcis Limited** ("the Company") on 01st April, 2025, we have been appointed as a scrutinizer to process and scrutinize the postal ballot process in respect of the two resolutions as circulated in the Postal Ballot Notice dated 01st April, 2025.

To enable wider participation of shareholders, pursuant to the provisions of Section 108 of the Companies Act, 2013 and the Rules framed thereunder vide the Companies (Management and Administration) Rules, 2014, as amended and pursuant to Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements), 2015 ("Listing Regulations"), listed companies, are required to provide e-voting facility to their shareholders on all shareholder resolutions to be passed at the general meetings or through Postal Ballot. Since the company falls within the requirements as specified in the Companies Act, 2013 and the above mentioned Listing Regulations, remote e-voting which has been made applicable, the company has provided for the same.

The Company accordingly has made arrangements with the system provider Central Depository Services Limited (CDSL) for providing a system of recording votes of the shareholders electronically through remote e-voting. The company has also accordingly made arrangements through its Registrar and Transfer Agent, MUFG Intime India Private Limited (Formerly known as Link Intime India Private Limited) (herein after referred as "RTA") to set up the remote e-voting facility on the CDSL e-voting Website : <https://www.evotingindia.com>.

The Company through RTA has also uploaded the resolutions together with the explanatory statement in which remote e-voting is required and for generating Electronic Voting Sequence Number (EVSN) by the system provider. All necessary formalities in compliance with the requirements specified by CDSL, the system provider has been done by the company through its RTA.

Necessary instructions in this regard to be followed by the shareholders have also been duly mentioned in the Postal Ballot Notice dated 01st April, 2025 sent to the shareholders by way of email. The Register of Members was made up for the purpose of dispatch of postal ballot notice to the shareholders as of Friday, 16th May, 2025, being the cut-off date.

We report that the Postal Ballot Notice dated 01st April, 2025, under section 110 of the Companies Act, 2013 read with the Rule 22 of the Companies (Management and Administration), Rules, 2014 and MCA and SEBI Circulars, were dispatched to all the shareholders electronically on 23rd May, 2025 to 48954 members whose email IDs are registered with the Company / Depository Participants. As per the MCA Circulars and SEBI Circulars, the Company was not required to send hard copy of the Notice along with postal ballot form and postage prepaid self-addressed business reply envelope, to the members whose email address are not registered.

The advertisement in English language and in Vernacular language was published by the company on 24th May, 2025 in "The Indian Express", English Newspaper and in "The Financial Express" vernacular newspaper, informing about the completion of dispatch of the Postal Ballot Notices by email, to the shareholders along with other related matters mentioned therein.

The remote e-voting period commenced on Tuesday, 27th May, 2025 at 9.00 a.m. (IST) and ended on Wednesday, 25th June, 2025 at 5.00 P.M. (IST).

We report that all the votes cast by e-voting through CDSL received up to 5.00 PM on 25th June, 2025, being the last date fixed by the Company for e-voting, were considered for our scrutiny.






