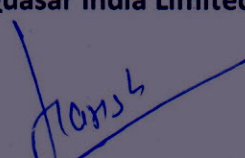

सरकार ने पेट्रोलियम व प्राकृतिक गैस नियमावली-1959 को संशोधित कर पेट्रोलियम की परिभाषा में शेल को भी जोड़ा है। इससे निजी क्षेत्र की कंपनियां उन तेल-गैस प्रखंडों में शेल गैस की

भी खोज और उत्पादन कर सकेंगी जिनका परिचालन वे पहले से कर रही हैं। पेट्रोलियम मंत्रालय की अधिसूचना में कहा गया है कि पेट्रोलियम से तात्पर्य प्राकृतिक रूप से पैदा होने वाले हाइड्रोकार्बन (तरल कार्बन) से है, चाहे वह प्राकृतिक गैस के रूप में हो या तरल, गाढ़े चिपचिपे या ठोस अवस्था हो या इनके मिश्रित रूप में हो। लेकिन इसमें कोयला, लिग्नाइट और पेट्रोलियम के साथ घटित होने वाला हेलियम शामिल या किसी तरह का कोयला शामिल नहीं होता। शेल गैस अवसादी भूगर्भीय चट्टानों में पाई जाती है। इस समय अमेरिका में इसका खूब दोहन हो रहा है। इससे पहले तरलकार्बन (हाइड्रो कार्बन) की परिभाषा में शेल
