The Stakeholders Relationship Committee (SRC) of the Board of Directors of the Company has vide a circular resolution dated November 25, 2025 approved the allotment of 72,331 Equity Shares of ₹5/- each on November 26, 2025 to the eligible employees who have exercised their options granted under the ESOP Schemes detailed hereunder:
