Subject: **Revised** Intimation under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015

Dear Sir/Ma'am,

This is in continuation of disclosure made on December 24, 2025. Pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI LODR Regulations") and in continuation of disclosure made in the Red Herring Prospectus dated November 26, 2025, we would like to inform that the National Faceless Assessment Centre, represented by Addl/joint/deputy/assistant commissioner of income tax/ Income Tax officer, Income Tax Department, Ministry of Finance, Room no. 401, 2nd Floor, E-Ramp, Jawarlal Nehru Stadium, Delhi – 110 003, had issued an Assessment Order dated September 27, 2021 under Section 143(3) of the Income Tax Act relating to Financial Year 2017-18 (assessment year 2018-19) raising a demand of ₹ 779.56 Mn. ("Order") and aggrieved by such Order, Aequs had filed a Writ Petition dated October 21, 2021 before the Hon'ble High Court of Karnataka at Bengaluru seeking the said Order to be stayed and now with respect to the said Writ Petition, Hon'ble High Court of Karnataka at Bengaluru has issued an order digitally signed on December 18, 2025 setting aside the Order and allowing the appeal and the copy of which is received by the Company on December 24, 2025.

This revised intimation is being made in compliance with the applicable provisions of the SEBI LODR Regulations and for the information of the Stock Exchanges and stakeholders.
