Sub: Additional Details Required for Corporate Announcement filed under Regulation 30 of SEBI (LODR) Regulations, 2015.

With reference to our press release dated December 24, 2025 pursuant to Regulation 30 read with Para B of Part A of Schedule III of the Listing Regulations, SEBI Master Circular no. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024 and SEBI Circular SEBI/HO/CFD/CFD-PoD-2/CIR/P/2024/185 dated December 31, 2024, we hereby inform that, the Judgment and Decree in the matter Pritish Nandy Communications Limited (PNC) v/s. Saboo Films Private Limited (Defendant No 1), Mrs. Rita Rahul Rawail (Defendant No 2) and others was passed on 31st October 2025 by City Civil Court, Mazgaon, Mumbai. PNC's advocate applied for certified copies on 4th November, 2025 and the same were delivered on 16th December 2025.

PNC was in the process of seeking advice from its advocates for challenging the order on the ground that the decree is only against Defendant No 1 and the decree exonerates Defendant No 2. By challenging the order, PNC is seeking recovery of decretal amount from Defendant Nos. 1 and 2 jointly and severally.

Accordingly, PNC filed an appeal in before the Hon'ble High Court, Bombay on 23rd December 2025 at 16:33 Hrs against the impugned Judgment and Decree and provided an update of this material developments to the exchange as stated under Regulation 30 of Regulation 30 of SEBI (LODR) Regulations, 2015 by issuing a press release on 24 December 2025 at 15.22 Hrs. The receipt of the said intimation is enclosed herewith. The said disclosure was made within 24 hours of filing of the appeal before the Hon'ble High Court, Bombay.

PNC further wishes to clarify that, order/ judgement is in favour of the Company. There was no intention whatsoever to withhold or delay in disclosure of the matter to the Stock Exchange.

Further, considering the sensitivity of the Company's business, the Company is of the view that the said order is not required to be placed in the public domain.

The requisite information is given in Annexure A.
