I confirm that there are no other commitments or obligations outstanding towards the Company, except those already known to me. Further I don't want any management position in the Company.


I take this opportunity to thank the Board of Directors and the management for the support and cooperation extended to me during my association with the Company. I wish the Company continued success in the future.
