**Sub: Outcome of Board Meeting held on 27<sup>th</sup> January, 2026 under Regulation 30 of the SEBI (LODR) Regulations, 2018**

This is with reference to our Letter of Offer dated December, 20<sup>th</sup> 2025 on raising of fund by issuing 53,94,635 equity shares of face value of Rs. 10/- each (“equity shares” or “rights equity shares”) for cash at a price of Rs. 10/- per Rights Equity Share (“the issue Price”) aggregating upto Rs. 5,39,46,350/- (“the issue”) on a rights basis to the public eligible shareholders of our company in the ratio of 1 (One) Rights Equity Share for every 2 (two) equity share held by eligible shareholder as on Record Date i.e. Tuesday 23<sup>rd</sup> December, 2025. This is to inform that the Meeting of the Board of Directors held today i.e. on 27<sup>th</sup> January, 2026 (which commenced at 3:00 p.m. and concluded at 8:45 p.m.), has, inter alia, approved the following:

**1. Allotment of Right Equity Shares**

Pursuant to Regulation 30 of SEBI (LODR) Regulations, 2015, the Board of Directors at its meeting held today i.e. on 27<sup>th</sup> January, 2026, inter-alia has considered and approved the allotment of 53,94,075 Right Equity Shares of face value of Rs. 10/- each for cash at a price of Rs. 10 per Right Equity share at par (‘the issue Price’) in terms of Letter of Offer dated 20<sup>th</sup> December, 2025 in accordance with the Basis of Allotment finalized in consultation with the Designated Stock Exchange and the Registrar to the issue. The remaining 560 shares will not get allotment as the allotment need to be done in multiple of lot size of **1,725** equity shares.

The new Equity shares allotted shall rank pari-passu in all respects with the existing Equity Shares in the Company. The requisite compliances with respect to credit of the aforementioned Equity Shares in the demat accounts of the Shareholders shall be completed in due course. The details of Company's Equity Share Capital before and after the allotment of 53,94,635 Equity Shares as aforesaid are given below:
