SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 date July 13, 2023, we wish to inform that, the board at its meeting held on 8th February, 2025 had inter-alia considered and approved the filing of suit/court case for recovery of the amount of Rs.50,03,700/- (Rupees Fifty Lakhs Three Thousand Seven Hundred Only) due as at 31.1.2025 with further interest due, till the date of filing, against M/s. AKR Construction Limited and also against the guarantor Sri A. Krishna Reddy. Accordingly, a case in the civil court has been filed against M/s. AKR Construction Limited and also against the guarantor Sri A. Krishna Reddy for the recovery of Rs.50,48,700/- (Rupees Fifty Lakhs Forty Eight Thousand Seven Hundred Only) as at 5.3.2025 with further interest due.

Brief Details of Dispute/Litigation	<p>M/s. AKR Construction Limited (borrower), had borrowed an amount of Rs.15,00,000/- during the year 2008 and since about last 6 years the company is not paying even the interest amount. After continuous follow up, the Borrower Company has issued cheque for a part of the loan amount of Rs.37,00,000/- but the same was dishonoured hence, Ushakiran Finance Limited (UFL) has already filed a cheque bouncing case against AKR Construction Limited. Later Sri A. Krishna Reddy, Guarantor has issued another cheque for Rs.15,00,000/- and the same was also dishonoured and hence another case for cheque bouncing has been filed against Sri A. Krishna Reddy, Guarantor and these cheque bouncing cases are presently pending in the court. AKR Construction Limited is under CIRP however AKR Construction Limited obtained stay from the Hon'ble NCLAT.</p> <p>As AKR Construction Limited has not paid any amount since about 6 years and the Board of Directors of Ushakiran Finance Limited at its meeting held on 8-2-2025 has resolved/approved to file a suit for recovery of amount due from AKR Construction Limited and against Sri. A. Krishna Reddy, Guarantor. Fresh case in the civil court has been filed</p>
