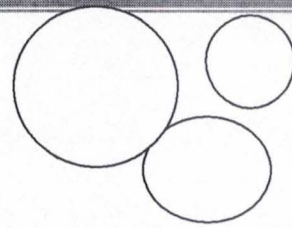

The meeting commenced at 05:00 P.M. and concluded at 05:40 P.M.

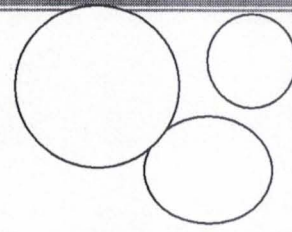
