Regulation 42(2) of SEBI (LODR) Regulations, 2015 relates to “record date” for the purposes mentioned in Regulation 42(1). Since we are not fixing record that for any of those purposes, Regulation 42(2) does not appear to be applicable in our case.

Regulation 42(5), which relates to closure of transfer books (for securities held in physical form) appears to be applicable in our case. But, the same is now only of academic interest as physical transfer of shares is no longer permitted.
